Belize Spa Series: 1000, 1500, 2000, 2500

THE MANUFACTURER OF BELIZE SPAS: CSI, EXTENDS THIS LIMITED WARRANTY SOLELY TO THE ORIGINAL PURCHASER OF THE ABOVE-LISTED BELIZE SPA INSTALLED FOR RESIDENTIAL USE WITHIN THE UNITED STATES. WARRANTY IS NON-TRANSFERABLE AND ONLY IN EFFECT AT THE ORIGINAL INSTALLATION SITE.

TEN YEARS SPA SHELL The manufacturer warrants against water loss due to defects in the spa shell for ten years from the original date of purchase.

THREE YEARS PLUMBING & SHELL SURFACE The manufacturer warrants the interior surface of the spa shell against blistering, cracking, or delaminating for three years from the original date of purchase and warrants factory-installed plumbing against water loss due to defects in workmanship and materials for a period of three years from the original date of purchase.

TWO YEARS EQUIPMENT & CONTROLS The manufacturer warrants the spa's electrical equipment components, specifically, pump(s), heater, and control system against malfunctions due to defects in material and workmanship for two years from the original date of purchase.

WARRANTIES FOR OTHER COMPONENTS

All other non-specified items, including but not limited to light bulbs, light lenses, fuses, headrests, cabinet finish, spa cover and filter are warranted to be free of defects in workmanship and materials at the time of delivery.

PERFORMANCE

To obtain service in the event of a defect covered by this Limited Warranty, notify The Spa Depot or the manufacturer within 30 days, and use all reasonable means to protect the spa from further damage. Upon proof of purchase, the manufacturer or its designated service representative will correct the defect subject to the terms and conditions contained in this Limited Warranty. There will be no charge for parts as described in the warranty terms. All materials for examination must be returned to CSI freight prepaid. You may be assessed reasonable repairman travel mileage charges. Service call labor will be charged after six months from date of purchase. If the manufacturer determines that repair of the covered defect is not feasible, we reserve the right to instead provide a replacement spa equal in value to the original purchase price of the defective spa. In such an event, reasonable costs for removal of the defective spa, shipping costs for the replacement spa and delivery and installation of the replacement spa will be the responsibility of the spa owner. The replacement spa warranty will be equal to the balance, if any, remaining on the original spa. All disputes are subject to arbitration in the state of Oregon and subject to said laws.

EXCLUSIONS

Spas installed in commercial applications are excluded from any coverage whatsoever. This Limited Warranty is void if the manufacturer or its designated representative determines that the Belize spa has been subjected to alteration, neglect, misuse or abuse; if any repairs have been attempted by anyone other than the manufacturer or its designated representative; or if failure is cause by accident, acts of God or other causes beyond the control of the manufacturer. Neglect, misuse and abuse include any installation, operation or maintenance of the spa other than in accordance with the instructions contained in the owner's manual provided with the spa, including (but not limited to) damage caused by the operation of the Belize Spa outside the range of 40°F and 104°F; the failure to maintain proper water chemistry and chemical balance and the use of abrasive or improper cleaners. This Limited Warranty does not provide coverage for the insulating cover, any item attached to, or installed on, the spa after the date of manufacture, or for gaining access to any component for repair or replacement. The spa owner accepts liability

for repair work performed by anyone other than a representative designated by The Spa Depot or the manufacturer.

LIMITATIONS

This Limited Warranty takes the place of all other warranties, express or implied, in fact or at law, including implied warranties of merchantability and fitness for a particular purpose. All warranty service must be performed by the manufacturer or its designated representative. No agent, dealer, distributor, service company or other party is authorized to change, modify or extend the terms of this Limited Warranty in any manner whatsoever.

DISCLAIMERS

The manufacturer, The Spa Depot, and its representatives shall not be liable for any injury, loss, cost or other damage, whether incidental or consequential, arising out of any defect covered by this Limited Warranty, including, without limitation, loss of use of the spa and cost for removal of defective product, even if the manufacturer has been advised of the possibility of such damage. The liability of the manufacturer and The Spa Depot under this Limited Warranty, if any, shall not exceed the original amount paid for the defective product. Coverage under this Limited Warranty shall commence as of the original date of purchase and the duration of such coverage shall not extend for any reason whatsoever beyond the stated time periods. These disclaimers shall be equally applicable to any service provided by the manufacturer or its designated representatives.

LEGAL RIGHTS

This Limited Warranty gives you specific legal rights. You may also have other rights which vary from state to state.

This warranty is effective for spas manufactured after 10/1/2005.
