Instructions

Specifications

- Fits in most filters.
- Handles up to a 1000 gallon spa.
- Lasts 4 months.
- Easy to set reminder dial for product replacement.
- To be used in conjunction with a low bromine or low chlorine support and ozone if desired.

Spa Start Up

- Always drain and refill spa every 3-4 months.
- Clean or replace filter cartridge when dirty (Follow manufacturers instructions).

WATER BALANCE GUIDELINES

Balance water according to the chart.	pH:	7.2 - 7.8
• Shock spa to remove all contaminants. (Follow manufacturers directions.)	Total Alkalinity:	60 - 120
	Calcium Hardness:	150-300
	Total Dissolved Solids:	<2000
	Free Chlorine:	.5 - 1ppm
	Free Bromine:	1 - 2 ppm

Installing SPA FROG[®]

1. Set reminder dial on SPA FROG[®] to 4 months from month of installation. Turn dial with a coin.

2. Place SPA FROG[®] in one of the following locations in spa:

a) Majority of Spas - Insert SPA FROG[®] inside filter cartridge core (**Diagram A**). Do not allow SPA FROG[®] to sit too low in the filter. If blocking water flow install in filter well (**Diagram B**). If SPA FROG[®] is inside a standpipe, attach a string to the FROG[®] head handle for easy removal.

b) High Flow Spas - On skimmer filters with 2.5 HP or larger pump motors, place SPA FROG[®] outside the filter cartridge (**Diagram B**).

c) Small Cartridge or Other Spas - Place SPA FROG[®] in skimmer basket (**Diagram C**).

If unit is too tall, cut rod at hash marks to shorten.

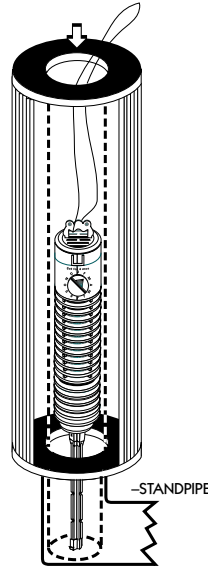


Diagram B -
High Flow Spas In Filter Well

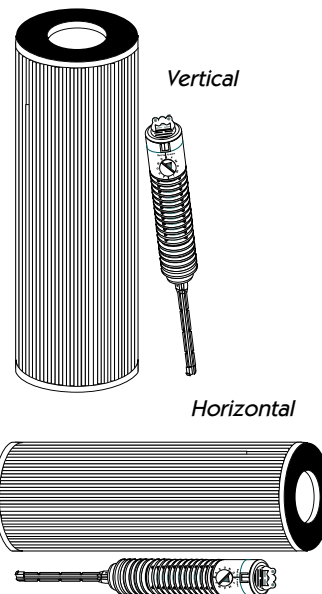
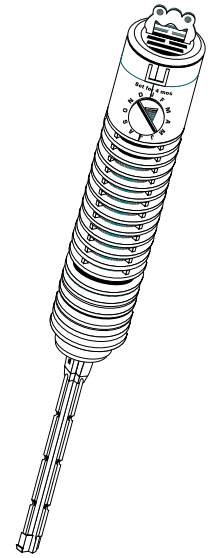
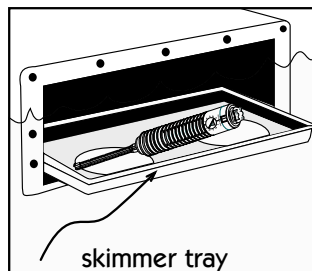

Regular Spa Care



1. Run filtration system a minimum of four hours per day.



2. Regularly test water for pH, total alkalinity and chlorine or bromine levels.

3. Maintain a .5-1 ppm chlorine or 1-2 ppm bromine level at all times.



4. Shock the spa with a chlorine or non-chlorine shock once a week or if water looks hazy.

Set for 4 mos.



5. Remember to replace SPA FROG[®] and to drain and refill the spa every four months.
